ORDER No. 56

WHEREAS, in pursuance of clause (d) of sub-section (2) of Section 9 read with sub-section (2) of Section 4 of the Delimitation Act, 2002(33 of 2002), as amended by the Delimitation (Amendment) Act, 2003 (3 of 2004), the Delimitation Commission has passed its final order (Order No. 49) determining the extent of Assembly and Parliamentary Constituencies in the State of Karnataka on 14th June, 2007; and

WHEREAS, the Commission has notified its final order dated 14th June, 2007 vide its notification No. 282/KT/2007-Vol. V, dated 2nd July, 2007, in the Gazette of India and the State Gazette of Karnataka Government; and

WHEREAS, in the Commission's above said order dated 14th June, 2007, Ward no. 4 of Shimoga CMC has been included in the extent of 111-Shimoga Rural (SC) Assembly Constituency in Table-A showing the extent of the Assembly Constituencies ; and

WHEREAS, after publication of final order it has been brought to the notice of the Commission by the Chief Electoral Officer, Karnataka, vide his letter

no. DPAR 13 CHUKSHEVI 2008 dated 12th March, 2008 that some discontiguity was appearing in the extent of 111-Shimoga Rural (SC) AC; and

WHEREAS, the Chief Electoral Officer, Karnataka has obtained and sent report dated 10th March, 2008 from the District Election Officer and Deputy Commissioner, Shimoga, confirming that Ward no. 4 of Shimoga CMC lies in the heart of the city and will have no connectivity with the remaining portions of the 111-Shimoga Rural (SC) AC and therefore 111-Shimoga Rural (SC) AC will not be a geographically compact area; and

WHEREAS, the State Election Commissioner, Karnataka who is ex-officio Member of Delimitation Commission, vide his letter no. SEC.1.DLC.2008 dated 24th March, 2008, has stated that inclusion of ward no. 4 in 111-Shimoga Rural (SC) AC will form an island within 113-Shimoga AC; and

WHEREAS, the State Election Commissioner, Karnataka, in his letter mentioned above, has stated that this is a bonafide error occurred on account of wrong map furnished by the Deputy Commissioner, Shimoga at the time of finalizing the Order in respect the State of Karnataka ; and

WHEREAS, the Commission has considered and verified the facts brought to its notice by the Chief Electoral Officer, Karnataka in respect of 111-Shimoga Rural (SC) and 113-Shimoga Assembly Constituencies in the light of geographical contiguity and the provisions of Section 9 (1) (a) of the Delimitation Act, 2002.

NOW THEREFORE, by way of this corrigendum to correct the above anomaly of formation of island due to inclusion of Ward no. 4 of Shimoga CMC in

111-Shimoga Rural (SC) Assembly Constituency, and having regard to the provisions of the Delimitation Act, the Delimitation Commission hereby orders that --

- (i) Ward No. 4 of Shimoga CMC shall be excluded from the extent of 111-Shimoga Rural (SC) AC and included in 113-Shimoga Assembly Constituency. Remaining extent of both the Assembly Constituencies shall remain unchanged.

The Commission's order No. 49, dated 14th June, 2007 stands amended accordingly.

This order issues with concurrence of all members of the Delimitation Commission.
