ORDER NO. 58

WHEREAS, in pursuance of clause (d) of sub-section (2) of Section 9 read with sub-section (2) of Section 4 of the Delimitation Act, 2002(33 of 2002), as amended by the Delimitation (Amendment) Act, 2003 (3 of 2004), the Delimitation Commission has passed its final order (Order No. 34) determining the extent of Assembly and Parliamentary Constituencies in the State of Uttar Pradesh on 5th December, 2006; and

WHEREAS, the Commission has published its final order dated 5th December, 2006 vide its notification No. 282/UP/2006, dated 18th December, 2006 in the Gazette of India and the State Gazette of Uttar Pradesh Government; and

WHEREAS, the Commission has vide order No. 41 dated 19th March, 2007 published in the Gazette of India and the State Gazette of Uttar Pradesh Government on 30th March, 2007 amended the said Order (Order No.34); and

WHEREAS, in the Commission's above said order dated 5th December, 2006 as amended, PC 19-Makanpur of 2-Loni KC has been included inadvertently in 53-Loni AC of Ghaziabad District in Table A showing the extent of Assembly Constituencies appended to the said order; and

WHEREAS, these discrepancies escaped notice during the discussions and the meetings of the Commission, as a result of which Makanpur Patwar Circle has formed an island in 53-Loni AC; and

WHEREAS, the Commission got factual position verified through the Chief Electoral Officer, Uttar Pradesh in respect of Assembly Constituencies in Ghaziabad District; and

WHEREAS, the CEO, Uttar Pradesh has on the basis of reports from the DEO, Ghaziabad confirmed vide letter dated 4th January, 2008 the formation of an island in 53-Loni Assembly Constituency as mentioned above.

NOW, THEREFORE, by way of corrigendum to correct the above errors arising from inadvertent slips, the Delimitation Commission hereby orders the inclusion of Patwar Circle 19-Makanpur of 2-Loni KC in 55-Sahibabad Assembly Constituency of Ghaziabad District and excluding it from the extent of 53-Loni Assembly Constituency in Table A of the said order.

The Commission's order No. 34 dated 5th December, 2006 stands amended further accordingly.

This order issues with concurrence of all members of the Delimitation Commission.
