**Subject:** Right to Information Act, 2005-Designation of Public Information Officers  
and Assistant Public Information Officers-regarding.

Sir/Madam,

I am directed to say that the Government of India has passed the Right to Information Act, 2005, and the same has been published in the official gazette of Government of India on 21<sup>st</sup> June, 2005. It provides that the Act shall come into force on the one hundred and twentieth day of its enactment.

Under Section 5 of the said Act, every public authority shall, within 100 days of the enactment of the said Act, designate as many officers as the Central Public Information Officers or State Public Information Officers, as the case may be, in all administrative units or offices under it even at the sub-divisional or sub-district level.

The Commission has decided that the following officers may be designated as Public Information Officers (PIO) and Assistant Public Information Officers (APIO) in the offices of Chief Electoral Officers:-

It has also been decided that District Election Officers may be asked to designate suitable officers as Public Information Officers (PIO) and Assistant Public Information Officers (APIO) in their respective offices.

You are requested to take necessary action and intimate the names and addresses of the designated officers to the Commission within one week from the date of issue of this letter.

Subject: **Appellate Authority in respect of the Office of the Chief  
Electoral Officers and the Office of District Election Officers.**

Sir/Madam,

I am directed to draw attention to Section 8 Sub-section (iii) of the Right to Information Act, 2005 wherein the particulars of the Appellate Authority need to be mentioned by the Public Information Officer (PIO) when the PIO rejects a request for information.

2. In this connection, it is stated that under Section 19(1) of the said Act appeal against the decision of the PIO can be made to such officer who is senior in rank to the Central Public Information Officer or the State Public Information Officer as the case may be.

3. In view of the above, the Commission has decided to designate the Chief Electoral Officers (CEOs) as the Appellate Authority in their offices for the purpose of the Right to Information Act, 2005. In so far as the Appellate Authority for the Office of the District Election Officer (DEO) is concerned, an officer, who is senior to the PIO of the District in terms of Section 19(1) of the Act, or the DEO may be designated as the Appellate Authority.

**RIGHT TO INFORMATION ACT, 2005**  
**INFORMATION IN RESPECT OF THE DELIMITATION**  
**COMMISSION OF INDIA**

**(i) The Particulars of the Delimitation Commission its functions and duties.**

The Delimitation Commission was constituted consequent upon enactment of the Delimitation Act, 2002 (33 of 2002) published in the extraordinary issue of the Gazette of India dated 4<sup>th</sup> June,2002. It is a temporary Statutory Body, which was constituted in July 2002 and became functional in November/ December 2002. The Constitution of India read with the Delimitation Act 2002 has vested the power in the Delimitation Commission of India to readjust the territorial extent of Assembly and Parliamentary Constituencies, on the basis of census figures 2001 as ascertained and published by the Registrar General and Census Commissioner, India, in all States/UTs having a Legislative Assembly, except J & K, for the purpose of elections to the House of the People and Legislative Assemblies, without, however, altering the total number of seats in that House/Assembly.

The Commission consists of the following Members:-

In addition, five members of the House of the People and five members of the Legislative Assembly of the State concerned act as Associate Members of the Commission in relation to the work relating to the State concerned. These Associate Members are nominated by the Speaker of the House/Assembly concerned; and when the number of members of the House of the People elected from a State is five or less, all such members act as Associate Members.

The Commission has a separate Secretariat at Nirvachan Sadan, Ashoka Road, New Delhi, consisting of about 50 officials (including consultant and contractual Staff), in a hierarchical set up. In terms of sub-section (6) of section 5 of the Delimitation Act, 2002, the Secretary to the Election Commission shall be the ex-officio Secretary of the Delimitation Commission and shall discharge his functions with the assistance of the employees of the Election Commission under the supervision of the Chairperson of the Commission.

One Officer on Special Duty to Chairman cum Deputy Election Commissioner (Delimitation) is the senior most officer in the Secretariat to assist the Commission. There is functional and territorial distribution of work in the Commission. The work is organized in Branches and Sections; each of the last mentioned units is under the charge of a Section Officer. The work is divided between the sections State-wise. For the purpose of other items of work, the Delimitation Commission takes help of functional divisions of Election Commission of India, namely; Planning, Judicial, Administration, Information Systems, Media and Secretariat Co-ordination, etc. (For further details, please see Delimitation Commission's website at <http://www.delimitation-india.com>).

At the state level, in the discharge of its functions the Delimitation Commission seeks the Secretarial assistance of the Chief Electoral Officer of the State concerned, who is appointed by the Election Commission under section 13A of the R.P. Act 1950 from amongst senior civil servants proposed by the concerned state government. He is, in most of the States, a full time officer and has a small team of supporting staff. (For further details please see Election Commission's website at <http://www.eci.gov.in>)

**(ii) The powers and duties of its officers and employees.**

The Delimitation Commission is empowered to redraw the boundaries of Parliamentary and Assembly Constituencies of all States and Union Territories having a Legislative Assembly (except J & K State) on the basis of census figures 2001 without altering the total number of seats. The Commission is also empowered to determine the number of seats to be reserved for Scheduled Castes and Scheduled Tribes on the basis of census figures 2001 as determined by the Registrar General and Census Commissioner, India.

**(iii) The Procedure followed in the decision-making process, including channels of supervision and accountability.**

The Commission transacts its business by holding meetings and also by circulation of papers. All Members have equal say in the decision making of the Commission. The Commission, from time to time, delegates some of its executive functions to its officers in its Secretariat under the supervision of the Chairman.

There is functional and territorial distribution of work in the Commission. The work is organized in Branches and Sections, each of the last mentioned units is under the charge of a Section Officer. The work is divided between the sections State-wise. For the purpose of other items of work, the Delimitation Commission takes help of functional divisions of Election Commission of India, namely; Planning, Judicial, Administration, Information Systems, Media and Secretariat Co-ordination etc. The territorial work is distributed among separate units responsible for different Zones into which the 27 constituent States and 2 Union Territories (having a Legislative Assembly) of the country are grouped for convenience of management. The details of distribution of work in the Commission is as follows: -

**(iv) The norms set by the Commission for the discharge of its functions.**

The Commission transacts its business in accordance with the relevant provisions of the Constitution and the Delimitation Act. For these purpose, the Commission has laid down detailed Guidelines and Methodology which can be seen at the website of the Delimitation Commission. All Members have equal say in the decision making of the Commission. The Commission, from time to time, delegates some of its executive functions to its officers in its Secretariat under the supervision of the Chairman.

**(v) The rules, regulations, instructions manuals and records, held by it or under its control or used by its employees for discharging its functions**

Its employees for discharging its functions are guided by the relevant provisions of the Constitution and the Delimitation Act, 2002, Manual of Election Laws containing the Representation of the People Act, 1950, etc. and the Guidelines and Methodology for Delimitation formulated by the Delimitation Commission.

**(vi) A statement of the categories of documents that are held by it or under its control**

The Delimitation of Parliamentary and Assembly Constituencies Order 1976, the Delimitation Act, 2002, the Constitution (Eighty Fourth Amendment ) Act 2001, the Constitution (Eighty Seventh Amendment ) Act 2003, Manual of Election law , are available in the Commission as well as in the offices of Chief Electoral Officers of all States and Union Territories. The latter three documents are also available at the official website of the Delimitation Commission.

**(vii) & (viii) The particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof.**

**A statement of the boards councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public.**

The Commission prepares its draft proposals in consultation with the Associate Members. Thereafter, the Commission publishes its draft proposals in the concerned State Govt. Gazette as well as in the Govt. of India Gazette inviting suggestions/objections from all interested with reference to the said proposals and specifies dates on or after which the proposals shall be further considered by it. The proposals are also published in two vernacular News Papers for information to General Public. It also fixes public sittings in one or more places in each state to consider the suggestions/objections received in response to its Public notice before issuing the Final Order.
