## NOTICE

The Delimitation Commission has published in the Gazette of India, Extraordinary and in the Assam State Gazette, both dated 22<sup>nd</sup> May, 2007, its proposals for the delimitation of Parliamentary and Assembly Constituencies in the State of Assam for the purpose of the elections to the House of the People and the Legislative Assembly of the State. The Commission invites objections and suggestions in relation to the same.

2. Copies of the gazette are available for reference, with the Chief Electoral Officer, State of Assam, and the Election officials in all the Districts in the State.

Any objections and suggestions to the proposals should reach the **Secretary, Delimitation Commission, Nirvachan Sadan, Ashoka Road, New Delhi-110001 on or before 1700 hrs on 06<sup>th</sup> June, 2007 (Wednesday)**. These will be considered by the Commission in public sittings in the State as per schedule given below: -

2. The Chairman, Delimitation Commission had a meeting with the Chief Minister, Assam with regard to holding of public sittings as per the above schedule. Thereafter, the Chairman held a press conference at Guwahati on 2<sup>nd</sup> June, 2007, indicating that the Commission shall review the decision to hold the public sittings as per the above schedule and take a decision. The said press conference has been widely covered in the press at Guwahati on 3<sup>rd</sup> June, 2007.

3. The Commission has accordingly reviewed its decision to hold public sittings in the State and has decided to go ahead with the holding of public sittings as per the schedule already notified. However, the Commission has decided to extend the date for receiving objections and suggestions to the draft proposals up to 11<sup>th</sup> June, 2007 at 17:00 hrs.

## NOTICE

The Delimitation Commission has published in the Gazette of India Extraordinary, and in the Assam State Gazette, both dated 22<sup>nd</sup> May, 2007, its proposals for the delimitation of Parliamentary and Assembly Constituencies in the State of Assam for the purpose of elections to the House of the People and the Legislative Assembly of the State. The Commission *vide* its notice dated the 22<sup>nd</sup> May, 2007 invited objections and suggestions in relation to the said proposals by the 6<sup>th</sup> June, 2007. The date was subsequently extended upto 11<sup>th</sup> June, 2007.

2. To consider the objections and suggestions received by the Commission, a schedule for holding the public sittings on 16<sup>th</sup> June, 2007 at Jorhat and on 18<sup>th</sup>, and 19<sup>th</sup> June, 2007 at Guwahati was notified by the Commission.

3. The public sittings, as scheduled, could not be held at the two places as the Commission decided to postpone the said public sittings keeping in view the reports in the newspapers and in electronic media that the people might violently disrupt the public sittings in protest against the ongoing delimitation process in the State.

4. The Commission *vide* its Order dated 18<sup>th</sup> June, 2007 observed that in the prevailing circumstances it did not see the possibility of any change in the situation with regard to opposition to Delimitation proposals. Therefore, in this surcharged atmosphere and in the prevailing situation it may not be of much use to hold the public sittings in the State as the public may be prevented from entering the venue of public sitting itself and may be even physically harmed. As a result, persons who had earlier made their suggestions and objections in response to the Commission's public notice dated 22<sup>nd</sup> May, 2007, may have

been deprived of making their oral submissions in support or elaboration of their earlier written submissions at the said public sittings. The Commission has, therefore, decided to invite further suggestions and objections, if any, or further clarifications and elaborations to the suggestions and objections already submitted by individuals, if they so desire.

5. Now, therefore, the Commission hereby invites further suggestions and objections, if any, from those persons who could not submit the same earlier, as well as further clarifications and elaborations from those persons who have earlier submitted their suggestions and objections by the 11<sup>th</sup> June, 2007, in response to the Commission's Notice dated 22<sup>nd</sup> May, 2007. Such persons who desire to give further suggestions and objections or clarify or elaborate on their earlier suggestions and objections, may now forward the same **by post to the Secretary, Delimitation Commission, Nirvachan Sadan, Ashoka Road, New Delhi-110001 on or before 17:00 hrs on 5<sup>th</sup> July, 2007.** The individuals who have made the suggestions and objections may meet any of the Member of the Delimitation Commission, if they desire to explain in person the suggestions and objections made by them with regard to draft delimitation proposals in respect of the State Assam.
